December 4th, 2018 HBBA General Meeting minutes

Meeting opened at 6pm - Called to order by Jill Matthews

Treasury Report: Current balance is \$3,753.84, we have one outstanding bill for Christmas trees of \$334.95

We need to further discuss our expense on the Billboards for advertising and possibly open it up to members to advertise at our price. We will need to discuss with Adams and figure out our pricing for next year.
