Outdoor exhibitor vendor area along Broadway, this show will have an old-time downtown feel. In addition to our hand selected eclectic artisan vendors, we will have HBBA member businesses and non-members participate with offering food, sweet treats and a Bangor brewed beer garden.

LOCATION: Broadway, Bangor PA 18013, between route 191 (1st Street) and Main St. **SET-UP:** 8am to 9:30am

VENDOR SPACE: 10' BY 10' Spaces all are outdoor **SPACE COST:** \$75 per space- Applications and fees must be received by August 1, 2019. Vendors must donate a tricky tray prize, gift card, merchandise, memorabilia, etc. for a drawing to be held that day. Tricky Tray items and ticket collection cups will be kept at your booth on display. Patrons put tickets in cups to win!

All Vendor Spaces must be set up prior to start of show. Vendors may use 10x10 tents (however vendors must have proper weights to anchor as set up will be on asphalt) Vendors must remain on premises for the duration of the event, no early departures or late setups are allowed for the safety of our patrons. There will be NO electric, wifi, or water hook up available. Please plan accordingly

You the Exhibitor waves any claim against HBBA, its workers and its subsidiaries, the sponsors, and the Borough of Bangor and assumes all liability for any loss or damage to your Exhibitors property entrusted to the premises as a result of attending this show. You will hold HBBA, its workers and its subsidiaries, the sponsor, the Borough of Bangor harmless & will indemnify HBBA its workers and its subsidiaries, the sponsors, and the Borough of Bangor against all liability for expenses arising out of any claim of injury or damage to any person or property, together with all cost in connection with the defense thereto, including attorney's fees. HBBA its workers and its subsidiaries, the sponsors, and the Borough of Bangor will not be liable for the fulfillment of this contract if the show is cancelled due to the threat of unsafe conditions, authority of the law, strikes, or Act of God. If the show is cancelled for any one of these reasons or all, the event will not be rescheduled & **there will be no refunds or credits of any kind. Outdoor vendors are strongly encouraged but not required to tent their vendor spaces at their own expense to ensure a great show rain or shine.**

HBBA retains the right to reject, eject, or prohibit any product or exhibit in whole or in part or to reject, or eject an Exhibitor or his representative(s) with or without giving cause. The Exhibitor agrees to collect and remit sales and use taxes in accordance with governmental regulations.

The Sponsor understands that their Sponsorship does not guarantee any results.

Exhibitors understand that they are fully responsible for their vendor areas and failure to clean up when breaking down will result in a \$50 fine for each vendor spot contracted. Vendors and Exhibitors understand they must be present for the entire show. Exhibitors **must be set up by 9:30 am day of the show** and all trucks cars & trailers must moved to vendor assigned parking area prior to 9:30am. Vendor vehicles will not be allowed on the closed streets until all patrons have left the Exhibitor area. If you show up late to the show **you will not be allowed to enter the vendor space and will not receive a refund or credit of any kind.** Vendor spaces are non-transferable and cannot be cancelled after August 1, 2019.

For the safety of our patrons, NO Alcohol (except in designated areas), Illegal Drugs or Weapons are allowed on the premises. No obscene or illegal, sale / presentation of goods services are allowed. No vehicles of any kind can operate during show on the closed streets. Failure to adhere to these standards will result in immediate ejection from the show.
